The Asia-Pacific region is one of the most underrepresented regions at the International Criminal Court (“ICC” or “Court”), with only 34% of countries in the region being party to the Rome Statute. This event, organized jointly by the Court and The Hague Project Peace and Justice, seeks to explore the engagement of the region with the Rome Statute system and encourage students and young professionals from the region to consider a career in international criminal justice and at the ICC. The Asia Pacific Forum started in 2018, aiming to facilitate an open dialogue about the Asia Pacific region’s engagement with and contribution to international criminal justice.
